Option 1 (MyEnergyAnalyzer online audit tool) and Option 2 (HEC In-Home Energy Surveys) DO NOT qualify as Certified Energy Audits for this program.

Rebate Calculations:

Certified Audit Initial Audit rebate = 50% of Audit cost up to a maximum of \$75. Final Audit rebate = 50% of Audit cost up to a maximum of \$75 after customer completes at least one qualified air sealing or insulation upgrade.

Audit Rebate Total not to exceed cost of audit.

Air Sealing = Customer spend X 50% up to Maximum Amount Rebate Amounts (with Certified Audit).

Insulation = Customer spend X 50% up to Maximum Amount Rebate Amounts (with or without Certified Audit).

Windows = \$30 per window or \$60 per sliding glass door unit or picture window (No Certified Audit required).

Rebate Eligibility:

1. Electric Heat includes: Heat pumps and electric resistance heating systems
2. Certified Audit - must be conducted by a participating BPI or RESNET certified auditor. A Certified Audit consists of:
 - Comprehensive Audit (Option 3) - invoice of cost, blower door results, detailed summary page.
 - Comprehensive Audit + HERS (Option 4) - invoice of cost, blower door results, detailed summary page, software analysis generating HERS rating.

NOTE: Blower door Post-tests are typically included with Option 3 and Option 4 energy audits.

Please discuss with your Certified Auditor.

3. Air Sealing 10% requires blower door pre- AND post-tests OR completion of substantial sealing as detailed by blower door pre-test and specification of work (proof) required to reach 10% reduction in air infiltration.
4. Air Sealing 20% and 40% requires blower door pre- AND post-tests.
5. Attic/Ceiling Insulation requires a starting "effective" value of less than or equal to R 24 (OR less than or equal to 8" of insulation). "Effective" R value considers framing members in the overall existing attic/ceiling R Value. A minimum of R 19 or 6" of insulation must be added.
6. Band Joist Insulation requires the band joist to be both air sealed and insulated with a minimum of R 10+ value OR foam air sealed plus existing R 10+ insulation. Band Joist minimum area is 100 lineal ft **OR** entire available band joist area (whichever is smaller).
7. Floor and Crawl Space Insulation requires lapped and sealed vapor barrier on unfinished crawlspace floor if deficient or absent.
8. Window Replacement - Windows must be rated as ENERGY STAR and/or National Fenestration Council with a U factor of .3 or less. Picture windows and sliding glass doors units that are 30 sqft or larger count as 2 windows.
